Re: 2025 Community Grants

## RECOMMENDATION

THAT the Council of the Corporation of Merrickville-Wolford allocate funds in the amount of \$12,000 funds and In-Kind requests in an estimated amount of \$8,075 for the Community Grant Program;

AND FURTHER THAT the Public Works Department and Emergency Services Department provide an accounting of the approximate staff time allocated to the functions supported by the grant to determine the true cost of the support provided by the Municipality;

AND FURTHER THAT Staff provide a revised structure and allocations policy prior to undertaking the 2026 budget.

## **BACKGROUND**

On April 23, 2019, Council passed By-law 23-2019, being a by-law to adopt a Community Grant Program Policy in order to set rules and eligibility requirements for applicants and to guide the decision-making process with respect to the allocation of the community grants each year. The Village of Merrickville-Wolford Community Grants Program provides limited financial support to community groups and organizations for projects or events that benefit and contribute toward the quality of life of local residents.

## ANALYSIS

At the Committee of the Whole meeting on February 10<sup>th</sup>, 2025, staff presented Council with the 2025 community grant applications. Council approved all In Kind requests, and allocated funding to the following community groups:
