Forbes Symon, Senior Planner, provided a brief overview of the Planning Report and the proposed zoning by-law amendment for File ZBA-05-2025 (Lackey).

The proposed zoning amendment would serve to amend Zoning By-law 23-08, as amended, by rezoning the subject property to allow a new build of a storage building on the lot without a main structure.

Agency comments were received from Enbridge Gas and no concerns were identified from agencies. No comments or concerns were submitted from the public in writing.

The applicant was provided an opportunity to comment on the application. The applicant was not present.

The opportunity was provided for members of the public to comment. No comments from the public were offered.

Council Members were provided an opportunity to ask questions or provide comments. There were no questions or comments.

There were no further questions. The Public Meeting for File ZBA-05-2025 was closed.

AND FURTHER THAT Staff be directed to engage a consultant or third-party services to organize and undertake a geotechnical study to specify the scope of work required and create tenders for the projects within a planned 3-year term. The intent being to release the tender documents and secure bids in the fall of 2025 or early 2026. With the understanding that funds for this service will be drawn from the Capital Infrastructure Reserve;

AND FURTHER THAT upon receipt of the bids, Council be provided with threshold amounts, using \$10,000,000 (ten million dollars) as a benchmark, for the purpose of determining a financial strategy that takes into account the impact to the ratepayer, the term of the loan, annual principal and interest payments and the tax rate that would be required to support the long-term initiative;

AND FURTHER THAT a similar process be used when developing the Master Infrastructure Plan proposed for the hard surface roads within the Village of Merrickville.
